PARKING LOT/GARAGE PARKING AGREEMENT

I agree to display such identification stickers/permits as may be required by ACDA Parking Services.

I agree to have only one vehicle per card/permit parked in the lot/garage at any one time.

I understand that storing a vehicle on ACDA premises is prohibited and vehicles observed as parked and unmoved for beyond three (3) calendar days are subject to tow, at registered owner expense.

I agree to pay a refundable deposit for my garage parking permit, which will be refunded, in full, within thirty (30) days of return of permit to ACDA:

\$20.00 Proximity Card
\$40.00 AVI Card

I agree to pay a \$5.00 replacement fee for a lost Hang Tag permit.

I agree to pay the current monthly rate for the applicable garage/lot. Proximity and AVI card payments shall be made by the first business day of the month, or the card will be deactivated.

I understand there will be no refunds to customers parking under this program after the first business day of the month. Any refunds prior to the first business day of the month are subject to a \$10.00 administrative/restocking fee.

I understand that ACDA shall not be responsible for damage to, or losses from my vehicle or its contents.

My signature below acknowledges my understanding of the following ACDA Parking Facility rules:

- Exceeding garage and lot speed limit 5 MPH may result in revocation of permit
- Pets may not be left unattended in vehicles
- Vehicles parked in more than one space are subject to Parking Infraction
- Abuse of proximity card, AVI card or any display style permit with the intent of securing unauthorized, unpaid parking may result in revocation of permit and parking privileges
- "Timing" of exit gates to exit without the use of a valid card or ticket, may result in issuance of Parking Infraction and/or revocation of parking privileges
- If parked where display of valid permit is required, original, valid month permit must be displayed or Parking Infraction may be issued
- Dual-Use, on-street permit holders must comply with all posted parking regulations, and/or all applicable regulations under State and Municipal Code
