



## 2010 Seasonal Tour Bus Loading Zone Application

Anchorage Community Development Authority, in cooperation with Municipality of Anchorage Traffic Engineering, is pleased to offer Seasonal Tour Bus Loading Zones for the 2010 Tourist Season. The applicable Municipal Code can be reviewed at [www.muni.org](http://www.muni.org) in the "Online Services" section, AMC 9.32.090.

A key component of the Anchorage Community Development Authority mission is to align parking programs with economic development. On-street tour bus staging downtown for passenger loading and unloading helps fuel our downtown economy by getting tourists into the downtown core to experience our beautiful city.

Here are the 2010 Seasonal Tour Bus Zone Program Requirements:

- Applicant must be an adjacent property owner/manager
- Applications must be submitted by April 19, 2010
- The approved 2010 season is May 15, through September 15
- Partial season applications will not be accepted
- A Seasonal Tour Bus Zone is defined as two (2) parking spaces, or 42 feet in length, of on-street parking
- Each zone carries a season fee of \$1,890.00
- Upon application approval, payment in full for the season, is due no later than May 14, 2010

Each Seasonal Tour Bus Zone impacts the balance between tourist accommodation and short-term parking for passenger vehicles, so each request is reviewed closely. To submit your application, please answer the following questions and return to ACDA at the address listed below, no later than April 19, 2010. Applicants will be notified of application status by Friday, April 30, 2010.
